Secondly, the specialties of Pathology and Bacteriology, and of Radiology have not been tabulated in Sections IV through VII of this report because of the diversity of billing patterns found among those practitioners. In particular, billings associated with individual practitioners are not necessarily indicative of individual activity levels, and so form an unreliable basis for FTE calculations. These types of practice are included in the per capita expenditure results of sections VIII, IX, and X.

#### FTE Definitions

In the tables in Sections IV and V, FTE calculations are based on all MSP payments (fee-for-service, salary and sessional). Sections VI through X are based on fee-for-service payments only. In the definitions that follow, "payments" or "receipts" refer to fee-for-service only, or the all-inclusive payments, depending on the section of the report in which they appear.

Nine alternative methods were used to compute FTE measures of physician supply, and the numbers used to identify them in the tables of the report are those that follow:

<u>Definition Number</u>	<u>Method of Supply Estimation</u>
1	Each physician receiving payments greater than \$50,059 (in 1986-87 fee-adjusted dollars <sup>2</sup> ) = 1 FTE; all others are counted as the proportion of their receipts to the mean receipts of their FTE peers.
2	Each physician receiving payments greater than \$50,059 (in 1986-87 fee-adjusted dollars <sup>2</sup> ) = 1 FTE; all others are counted as the proportion of their receipts to the FTE cutoff for that year (i.e. to \$50,509 in 1986-87 fee-adjusted dollars).
3	Each physician receiving payments equal to or greater than one-half the payment mean for his/her peer type of practice = 1 FTE; all others are counted as the proportion of their receipts to the mean receipts of their full-time type of practice peers.
