4. Provincial Executive Resolutions to the Special Convention
General discussion around this issue included the following comments:

"We should recommend that the membership has a say in every stage of the affiliation process"

"Convention should set out the guidelines for the implementation of any membership

decision"

"Convention should make a decision and this will help narrow the options"

"Convention should go through a process and will come out with one proposal which will go to a 'yes'-'no' ballot"

"The Convention might decide that there are a series of questions on affiliation to be answered and the convention would decide on the order of the questions"

"...should indicate to the Convention what the decisions to be made are"

4/ Prov Exec Resolutions to Convention - con't:

Mary Mabin Moved, Jet Blake Seconded

THAT the question of merger with a CLC affiliate or affiliation to the CCU should go to referendum

DEFEATED

Star Rosenthal Moved, Hester Vair Seconded

THAT the Provincial Executive recommend that any decision pertaining to affiliation be put to referendum ballot

WITHDRAWN (after discussion on what 'any decision' meant)

Suzanne Marria Moved, Sheila Perret Seconded

THAT the Provincial Executive recommend that the Convention's recommendation on affiliation be put to the membership through a tier process with each tier of the recommendation being put to the membership by separate ballot.

CARRIED

Suzanne, Bill and Hester each have, or have indicated that they will have, referendum ballot format proposals for tomorrow's meeting.

One idea that we informally discussed was the following ballot format for a Provincial Executive recommendation:

"All points are to be 'yes/No':

- Should AUCE remain independent Should AUCE seek affiliation with a national labour body
- 2. That AUCE should seek affiliation with aCCU rather than continue lobbying the CLC or merging with a CLC union
- 3. That AUCE continue lobbying CLC rather than merging with a CLC union"

We also discussed the idea of having the Convention instruct the Provincial Executive to negotiate merger with a CLC affiliate if merger is the decision of the membership.

There was a Concensus that discussion on Provincial Executive recommendations for a referendum ballot take place immediately after the visit with UFAWU President Jack Nichol, tommorrow morning, March 15th.
