Hester Vair, Vice-President added to her written report by saying that the Provincial needs an input from volunteers or that the Provincial hire another paid person or officer; she recommended that people think seriously about the commitment that is required for fulfilling the duties of an officer of the union at the Provincial level.

Reports from Provincial Executive Officers, con't:

Hester continued by saying that there is alot of information available at the Provincial Office and if there were more people involved at the Provincial level then it would be easier and more beneficial to the locals to have that information sent out. Two major criticisms Hester shared about the Provincial-Local relationship are: lack of time and energy from the dedicated few who do participate which is disproportionate to the amount of resources and information that could be made available, and, the Locals' attitudes towards the Provincial which ranged from complaining that the Provincial did not offer enough in terms of services, as well as claiming that whatever the Provincial did offer or could offer, they, the locals did not need, 'they'd do it for themselves', which seems contradictory. Re the Affiliation Committee. Hester chaired the committee for some months - the committee could have worked better but was prevented from doing so because: it was too 'unstable' in terms of changing reps from month to month, it was too large, too unwieldy, and the issue that formed the committee was too sensitive for people to deal effectively as a working group. On the positive side, there is much information on affiliation in general, and various unions, and labour centrals in particular, available at the Provincial Office. Hester ended her report be praising AUCE's ability to fight successfully for the rights and benefits of women workers, and she also mentioned that the structure of AUCE makes it possible for members to become involved at every level of the function of the union, that because membership involvement in encouraged, the union structure is de-mystified; Hester noted that other unions are starting to follow AUCE's lead in the fight for better contracts and worker benefits. See Appendix 'A'.

Sheila Perret, Secretary-Treasurer: submitted a written report and reiterated the position taken by the Provincial Executive and that is that the Provincial Office needs more assistance - perhaps a ½-time helper. She outlined the Shop Steward Seminar that was held for Local 5 and the lack of time available to organise more educationals for all locals. She stated that Provincial should seriously consider a per capita tax increase, in order to improve services, and that the Provincial should start making outright donations and grants to the Locals when they are on strike instead of only making long-term interest-free loans - that an increase in the per capita tax would be one way of increasing the strike fund. The written report is appendaged, Appendix 'B'.

Suzanne Marria, Provincial Organiser: Suzanne explained her observations on members general reactions to the Provincial Executive: On one hand, members want the Provincial to provide a multitude of services and resources, and on the other hand the membership will not give the Provincial Executive Table Officers enough resources themselves, to fulfill those demands - for example the Provincial is expected to provide information and servicing on many items, from contract research to job evaluations to grievance and arbitration assistance to educational seminars - but the membership is reluctant to have a minimal dues increase in order that the office can be staffed by one more officer who could be available for the requirements. She asked people to consider that the Locals of AUCE can do alot, depending on the outcome of the affiliation debate, and that members should consider carefully what they require of the Provincial Executive and the Provincial Office, and then make sure that they provide the means for the servicing and representation to be made.

Virginia Gibberd, Trustee - In addition to her written report, Ginny outlined the responsibilities as a member of the Trustees Committee; she explained that putting out the number of provincial referendums that were done this year, greatly taxed the energies of several members, the ballots require a greater amount of input by any AUCE meber - there is a terrible lack of volunteers. She also explained that it

Virginia Gibberd, Trustee - is a great opportunity to get to know other members of AUCE, through the ballot stuffing work-parties; and the work goes alot faster of course with more help. She mentioned that a constitutional amendment is forthcoming which will propose a revision of the Trustees responsibilities and the format for running a Provincial Referendum. She also explained the common difficulty in each local with the stipulation that ballots only be sent out to people whose names are on the per capita tax dues lists. So, theoritically, if mames are not on the lists that are sent with the labels, then a ballot cannot be sent to someone whose name is not listed but for whom there is a label, and the reason that label is submitted is because the member can remain in good standing up to 150 days after a per capita tax payments. FINANCIAL REPORT

Financial Statements are the grey pages in the 1980 Dockets, and include the audit. Sheila Perret, Secretary-Treasurer explained that the full income, the per capita tax cannot be verified, because Local 2 cannot confirm the amount of per capita tax owing since last year; the strike at that local in 1979 left the financial records unsettled and until the Local 2 audit is completed, Provincial cannot verify its income. The auditor's financial report was read through and several points were made, questions answered. Briefly:

Exhibit 'A' -

- Cash, the general fund = our bank balances, our petty cash and our shares account

- the Special Assessment account is a trust fund set up to collect the proceeds of the affirmative Special Assessment referendum of \$5 per each member of Locals 1, 4 & 5, for the benefit of Locals 2 & 6 because of the financial hardship they experienced as a result of the Local 2 strike at SFU. The breakdown will be approximately \$2600 for Local 6 and \$6200 for Local 2.

- Labour Canada Fund, is the money Provincial was granted by the Federal Department of Labour for the purpose of union education. These figures are estimates because since Local 2 cannot verify their membership and thereby the per capita tax owing as outlined above, it is, up to this point impossible to verify their

share of the proceeds from the Special Assessment.

- Accounts Receivable includes the amount of per capita that was owing to the Provincial at the time of the audit.

- Loans Receivable includes the \$10,000 long term interest-free loan made to SORWUC in 1978, and, \$960 to AUCE Local 1 and \$9723 to Local 6 to help with organising.

- Accounts payable refers to miscellaneous items that AUCE Provincial owed but were to be paid pending receipt of per capita income, at the time of the audit.

- Due to the Strike Fund, is the amount of money that would be payable to the strike fund, based on the per capita figures available.

- Unexpended General Funds as shown

- Deficit of \$1456 at the end of the year. Exhibit 'C'

- outines income and expenses

- per capita, self-explanatory; copier income, payments on copier use; interest is down from last year because the credit union stopped paying interest on the chequeing account
- expenses: Donations SFU 18, Vancouver Community Legal Assistance Society, SORWUC strikers at the Muckamuck, Planned Parenthood, etc; Library increased resources; Meetings and Conventions, higher due to some Affiliation Convention expenses; Office typing supplies, courier, cleaning supplies; Office Equipment leases, chairs, eqpt. service contracts; Rent slightly up from last year; (6) ...

Financial Report - con't

- expenses: Printing- up because of extra printing involved with publishing materials about affiliation, research, bulletins, ballot; Salaries - Secretary-Treasurer's salary, overtime, other members' part-time wages, general office assistance & benefits, lost wages; Appropriation to the Strike Fund we weren't able to make our obligation
- overall Deficit of \$1456

The AUDIT is APPENDIX 'E'

n.b. our to date obligation to the Strike Fund has accumulated to \$35,830 this year. we weren't able to make out strike fund appropriation this year, as the 1979 Annual Convention approved a budget that did not allow for the appropriation, in other words, a deficit budget was approved.

The BUDGET is APPENDIX 'F'

- The Provincial Executive has proposed an increase in the per capita tax and an increase in the appropriation to the Strike Fund.
- If we want to continue servicing the Locals we are in serious financial shape; the Convention must pass the per capita tax increase & if the Convention approves the increase, then the delegates and reps have the responsibility of lobbying for the referendum on the increase to pass; SP stated that it is unfair to the membership to pass a budget without also passing a per capita tax increase, when the approved expenses warrant an increase in revenue.
- Budget 'A' is the least desireable budget, without an increase in dues.
- several questions about the feasibility of approving budget before other business,
 which means after financial resolutions & constitutional amendments

WHEREAS the 367 CAIMAW workers at the Canian Kenworth and Paccar of Canada plants in Burnaby have been on strike since May 21st; WHEREAS the major issue in the strike is gaining equal pay for work of equal value by raising the wages of data processing workers to rates comparable to shop production workers; WHEREAS the employer has consistently refused to consider this proposal because of "a difference in philosophy" on the principle; WHEREAS winning wage settlements in accord with the principle of equal pay for work of equal value is an important means to eliminate the tradional job ghettoes left to women workers;

THEREFORE BE IT RESOLVED THAT AUCE declare wholehearted support for the CAIMAW strikers at Canadian Kenworth;
