General Discussion: after viewing and applauding Lisa's video about the "strike", we listened to a number of reports on the activities and plans of SAB(Kevin), LMSC(John), TAU (Mike)AUCE and Op.Sol. Business Agents meeting (Fairleigh). Fairleigh also gave a Treasurer's report.

Resignations etc.: Mike Howlett resigned as Recording Secretary for personal reasons. A motion of gratitude proposed by Lisa and seconded by Andre passed unanimously.

André is taking a leave of absence from the chair during the period of his fast. John will act in his stead.

Andre's Fast: Kevin and Paul Richter offered help in dealing with publicity in the later stages of the fast. André took time to acquaint members of the Alliance with his goals and motivations. A motion to set aside up to \$100 for publicity costs was proposed by Mike, seconded by Fairleigh and passed unanimously.

A.M.S.:

In view of the fact that AMS had in effect rescinded their decision on the possibility of hiring scab labour during strikes, it was proposed by André and seconded by George that their membership in the Alliance be reactivated. Carried unanimously.

The issue of increased tuition fees was noted as of great concern to AMS and to the Alliance. Support in principle was given to possible actions on Jan. 19th. To be discussed at mext meeting.

More gratitude: A motion of gratitude to Fairleigh, in connection with her heroic organising of the post-protest party, was proposed by Lisa, seconded by George and - yes you guessed it! - carried unanimously.
