- l. Grievances that are not settled at Step 2 are to be brought to the Grievance Committee, where a sub-committee will be struck to document and investigate the Grievance. There will be no discussion among the Committee members at that time. The said sub-committee will be responsible to bring back its report on the grievance to the Committee at its next meeting for discussion.
 - 2. The sub-committees will be volunteered.
