loan. No motion was passed by the membership to set up loans. Whole
issue will have to be cleared up at Sunday's meeting.

2. Contract Committee report- Dale McAslan

Contract Committee met today. They figured out the difference between
our proposal and the University's offer to be between \$400,000-500,000
over one year. Marcel called Burian and he said Kennedy had put it
through the computer and figured the difference to be 2%!

Board of Governors last night told Personnel to bargain with our proposal.
Board of Governors doesn't know our position on other monetary tems.
We should send them that info cause Personnel won't tell it like it is.

Two days of us and CUPE out on strike will cover the difference in the
proposals and the University will still be making money.

We should request a meeting with the Board of Governors Labour Committee.

Contract Committee will write a brief on our outstanding position.

that the Contract Committee write a brief as soon as possible explaining
our position on outstanding clauses. We will stress that we are willing
to meet and our willing to negotiate. This should be released to press.
PASSED.

Will request that Board of Governors pick the brief up from Union office.

3. Organization of office - Heather MacNeill

There is no division of labour in office. Everything confused. No people delegated to make decisions, no executive people ever around. Need someone to speak to press. Need someone responsible for looking after other unions. Need executive rep to refer people to. Need volunteers to make decisions as to picket duty when problems come up.

4. Picketing

- a) B.C. Fed meeting - problems with position of our pickets and fact that we are giving out passes to Union members. Fed doesn't like us playing with sanctimony of picket line. Problem areas are Firefighters and Hospital site, and residences.

Decided that our future policy will be that we do not talk to management, we talk to the Unions involved and leave it to them to make a decision about who is essential services and who should receive passes. The Unions can then call us and we will issue passes.

These problems will be straightened out at B.C. Fed meeting tomorrow morning at 10:00.

- b) Changing positions of pickets.

Gate #15 has been removed (for being too effective) and moved to gate #1.

Gate #12 has been removed and moved to gate #11.

Gate #16 has been removed and moved to gate #3.

Pickets at gate #2 should move back to turn around point.

Gate #14 will be moved behind entrance to Hospital parking lot.

- c) Security

Problems with gate #11, others being dark, cars going too fast, chances of being run over.

Suggestions to park cars with lights flashing on side of road behind picket line. Use flashlights, lanterns, etc.

Inform RCMP of measures we're taking to ensure our safety.
