Dear Sisters and Brothers:

You have recently endorsed the demand that the charges against the SFU 18, those people arrested on the AUCE Local 2 picket line, be dropped. We thank you for that support and are writing to ask for your participation in further defense activities.

An open defense meeting for the SFU 18 decided to organize a public meeting for Monday, June 18, 1979 at 7:30 p.m. in the Fishermen's Hall, 138 E. Cordova, Vancouver. The purpose of this meeting is to rally the support of the trade union movement in addressing ourselves to the larger issues of defending our right to strike, defending the sanctity of the picket line, and our opposition to police intervention against the labour movement, including attacks on picket lines. Since the first trial has been set for first in the Provincial Courthouse at 6263 Gilpin Street in Burnaby, the focus of this meeting will be the demand to drop the charges against the SFU 18.

The speakers invited to the meeting are those representing unions which are experiencing government repression: CUPW, UFAWU, SORWUC (Muckamuck Restaurant), CAIMAW (Endako Mines), and the Retail, Wholesale and Department Store Union (Adams Laboratories). From their immediate and bitter experiences, these speakers will be clarifying the relationship between the importance of the defense of the SFU 18 and the defense of the sanctity of the picket line. We feel that it is important for the labour movement in the province to show its strong and solid opposition to union busting tactics.

We therefore ask:

- that you personally attend and bring a delegation to the public meeting,
- that you prepare a statement to be read to the press expressing your demands that the charges be dropped against the SFU 18, and
- 3. that you personally attend the first trial.

It is imperative that the leadership of the trade union movement attend this public meeting and the first trial to demonstrate the support of the trade union movement for the legal right to strike. Only this support can ensure victory for the SFU 18 and for the labour movement in general.

Dear Sisters and Brothers,

The SFU I8 Defence Committee is asking for the participation of the trade union movement and others in developing the defence campaign for the I8 persons arrested on the AUCE local 2 picket line at Simon Fraser University. As your union or organization has expressed solidarity with AUCE or those arrested we would ask you to send representatives and publicize an open defence committee meeting on Monday, June 4, at 7.30 pm. at 950A Richards, in the C.U.P.W. office.

We feel the most effective defence is demonstrating strong public sentiment that the charges be dropped. We urge you to participate in the camapign to build this public support.

Current defence activities and proposals include soliciting statements that the charges be dropped and contributions to the legal defence fund, distributing information and speaking on the strike and arrests, a rally to be held downtown, a press conference, and preparations for the trials (the first of which is at the formation of the trials in provincial courthouse at 6263 Gilpin St., Burnaby).

The next public activity planned is a press conference at the SFU convocation on June 2 at the Queen Elizabeth Theatre. The purpose of this activity is to present statements from the labour movement, the academic community, and others, urging that the charges be dropped. This event will conclude with an imformational display and distribution of infomational material on the strike, arrests, and defence activities.


If possible, we would appreciate very much if you would present a statement to the effect that the charges be dropped to be read out on
