Thank you for taking time out of your busy schedule to go through Safety Supply Canadas' line of prescription Safety eye ware.

Attached herewith is the complete list of dispensing locations in the Vancouver and lower mainland area. I have highlited the Prescription Optical locations which include fourteen (14) branches in a variety of geographical locations. These dispensaries are the preferred contact point, as they have the full line of C.S.A. frames in stock.

At these locations, your employees would identify themselves, submit their prescription form, choose their desired frame (C.S.A. only) and be fitted by the dispenser. The average turn-around time would be three to four days, at which time the employee would return, evaluate the glasses (making sure of a proper fit), and then pay the preset price.

PLAN 1
