UNDER NO CIRCUMSTANCES MUST IT BE HELD LONGER THAN 60 DAYS. PERISHABLE PROPERTY, IF REFUSED BY CONSIGNEE, MUST, IN THE ABSENCE OF INSTRUCTIONS, BE SOLD IMMEDIATELY TO BEST ADVANTAGE, FOR ACCOUNT OF OWNERS.
