Dear Sirs:

With reference to your letter of November 21st, I beg to say that I am now informed that, as regards shipments to the former Austrian territory, Certificates of Origin are for the time being still required. These Certificates of Origin need not, however, be so called Consular Certificates of Origin i.e. certificates issued by German Consulates, the fee for which would be one per thousand, minimum RM 3,- (= \$1.20). They may be in the form of declarations by the exporter on the invoices, which declarations can be certified by the competent Board of Trade. The fee for certification in such cases would be, as stated before \$ 4.00.

If the declaration of the importer is signed before a Notary Public the fee for legalization of the notarial certificate would be 40 cents in case of invoice values up to 1000 Reichsmarks, and 80 cents for higher amounts.

A sur-charge of 10% (minimum 40¢) on the above-mentioned fees is made if the documents are sent to the Consulates and returned by mail. This charge is not made whenever the documents are presented at the office and called for again by messenger.
