120,000 POUNDS OF HALIBUT

About 120,000 pounds of halibut went up for sale on the local exchange at noon yesterday, and found a ready market at good prices.

H. C. Nunan, of the Atlin Fisheries, secured the Daisy, 3,000; Annie St. Leon, 7,000; and Alvide, 30,000 pounds at 7 1-8 cents. The M. T., No. 3, 10,000; Corona, 25,000; Helgeland, 30,000; and 15,000 from small craft went to the Cold Storage Company at seven cents a pound.

The Roald, an American boat, came in from Alaska with 10,000 pounds of fine spring salmon, which sold to the Cold Storage at 5 1-2 cents a pound.

APPROVED OF CHANGES TO  
BE MADE IN SCHOOL BUILDINGS

School Board At The Meeting Last  
Night Decided To Carry Out  
The Necessary Alterations.

At the meeting of the School Board last evening among other business that was transacted was the receiving of a report prepared through the kindness of the City Engineer, P. Lorensen, relative to changes that were deemed necessary in connection with the schools. This dealt with the alterations largely for the sake of safety from fire. There will be a picket fence placed along the cliff at the Borden Street School and some other alterations that were considered advisable.

The need of another teacher in the High School, in view of the fact that there is an increasing number taking that work, was brought up and it was decided that an additional teacher should be advertised for. This teacher will devote his attention for the most part to science and mathematics.

The resignation of H. Anderson from the teaching staff was received.

### SCHOOL BOARD TO HAVE MANUAL WORK

THIS SUBJECT WILL BE TAUGHT  
IN THE SCHOOLS  
NEXT TERM

Steps Taken To Secure The Equipment And Install It In  
Quarters.

The School Board at its regular meeting, held last evening, decided to go right ahead with the manual training in connection with the work next term. The step had been decided upon early in the year, but it was found impossible to get anything in shape earlier than at the beginning of next term. It has been decided now, in view of all the information that is available, that the work shall be carried to completion and a start made.

It was decided to advertise for a teacher for that branch of work. The Board further, on the recommendation of the committee that investigated the whole situation relative to quarters for the carrying of the work along, to select the old gymnasium of the Methodist Church, which was secured on a continued lease at the rate of \$180 a year.

It was decided to order the benches for the pupils. There will be twenty of these ordered at once. They are made by the Restmore Company, of Vancouver, and this type is the one that is recommended by the department at Victoria. It will be possible to take care of about twenty boys at a time in the class room with this number of benches. It is recommended that the classess should not be too large, as the teacher is not able then to give the proper attention.

### MANY TRAVELLERS ON ALASKAN ROUTE

PRINCE GEORGE HAD MANY ON  
BOARD ON FIRST  
TRIP

There Were Over One Hundred  
Round Trip Travellers  
On Board

The G. T. F. steamer Prince George, which left yesterday at noon on the first of the trips to Alaskan ports, was well patronized. Over ninety round trip travellers came north from the southern ports for the trip to Skagway and other Alaskan centres. At Prince Rupert this number was increased to some extent by travellers who had come over the train route and were waiting here.

There was, therefore, over 100 passengers on board when she left on the trip. For some time to come there are reservations made that makes the run assured of being a decided success.

ITALIANS SUCCESSFUL  
AGAINST AUSTRIANS  
IN PRESENT FIGHTING

Rome, June 14.—In the Lagarina Valley, in the Austro-Italian theatre of war, the Italians took by assault strong Austrian positions and repulsed heavy counter attacks by the enemy.

On the Posna-Astico front the Austrians penetrated the Italian lines at Molisina, but were later driven out. They were also repulsed with heavy losses in the Sugana Valley, in an attempt to advance east of Mauseo Torrent.

## Austrians Cannot Face Drive Of Russians German Move Foiled

Petrograd, June 14.—In their advance upon Czernowitz the Russians occupied the village of Sniatyn, twenty miles northwest of the first named city. In addition to the previous captures, the Russians have taken twenty officers, six thousand men, six guns and ten machine guns.

General Brusiloff's operations to flank the Austro-German army under General Von Linsingen is proceeding with wonderful rapidity. German reinforcements, brought here to drive a counter wedge at the wings of the apex of the Russian salient, has proven ineffectual.

The official war office announcement today says that the retreat of the Austro-Hungarians and Germans along the Galician and Volhynian fronts is proceeding so rapidly that only one thousand prisoners have been captured since yesterday.

The total number of prisoners taken by the Russians since the beginning of this big new offensive is one hundred and fifteen thousand, seven hundred officers and men.

750,000 GERMANS  
HAVE BEEN KILLED

Huns Have Lost Nearly Three Million  
Men Since Beginning  
Of War.

London, June 14.—Germans up to the end of May had lost 2,924,886 soldiers, of whom 734,412 were killed, according to a British official tabulation of the German casualty lists given out here. The compilation did not include German losses in naval engagements or in the fighting in the German colonies.

The British official statement quotes the German casualty lists for the month of May as placing the total German losses in killed, prisoners and wounded at 102,597. This number, it is pointed out, brings the German total losses, exclusive of naval and colonial casualties to 2,924,586.

The German figures in the May list, as enumerated in the British account, are as follows:

Dead, 22,471; wounded, 72,075;

### Provincial Government Has Sold Bonds At A Very Good Price

Victoria, June 14.—The Province of British Columbia has sold two million dollars' worth of its bonds, passed under the Ten Million Dollar Loan Act. The sale price obtained was at a trifle better rate than was obtained several months ago for a similar amount of bonds for ten years.

The sale made at 91 1-2, gives the loan on the per centage basis a rate of only 5.60.

CITY SOLICITOR HAS  
HAD LATE WORD OF HIS SON

Mrs. Peters Writing From England  
Tells Of Seeing Several From  
Prince Rupert.

Yesterday Fred Peters, City Solicitor, received a letter from Mrs. Peters, who is at present in England. The letter was written on May 23, the day following the departure of their son, Lieut. Gerald Peters for the front. Evidently, in about a week after that, he was into the thick of the fighting and was numbered among the missing.

From the letter it is gleaned that he had not completed his course at Shorncliffe when he was ordered to rejoin the regiment, his previous experience in the trenches being regarded as better than the technical training of the officers' course.

It is further stated in the letter that "Major" Gibson, who had been in England wounded, had returned to the front on the same date as Lieut. Peters. Mrs. Peters had seen many from Prince Rupert within recent times before writing. She mentions having received a letter in reply to one sent to Th. Collart, formerly of this city, and who is now serving with the Belgian army. She had written him with regard to her son Jack Peters, who is still unaccounted for.

## MANUAL TRAINING.

The introduction of manual training into the schools of this city we feel satisfied is a step in the right direction. There is an impression prevailing that, in the carrying out of that work in schools, there is an attempt made to make all boys carpenters more or less. This is a wrong idea. Manual training, while it has to do with the working up of wood for the most part, is not the making of carpenters. The teaching of drawing in the schools does not make all artists, and is never intended so to do. The teaching of drawing makes a boy and a girl more observant as to a variety of things, and is taught for the excellent training that it is for the pupil along wide lines. The same is true of manual training. It has been observed that the boys that take an interest in that branch of work are better students in other branches of the school work, where the main part lies in attention to books. There can be no doubt that the system is a good one. The only lament of the Board is that domestic science cannot be introduced at the same time. That, however, will follow, and the girls will get a training in that work while the boys are engaged in the manual training.

## ASSEMBLY WAS CRITICAL

Members Present At Gathering In Winnipeg Were Reprimanded.

Writing in the Winnipeg Free Press, a reverend correspondent of that paper, dealing with side lights on the General Assembly, has the following to say:

"The worthy moderator found it necessary to read the rules of good society to the fathers and brethren yesterday. By a coincidence that was conspicuous and condemnatory a whole drove of commissioners started for the doors when the short devotional service at 11:45 was begun. With a surprised look on his face the moderator got to his feet, exclaiming, 'Surely it is not possible that commissioners are leaving the assembly because the devotional services are to begin!' This stopped the exodus rather speedily. Later in the day after an able speaker sat down, the moderator expressed surprise again that commissioners should read the newspapers while they are being addressed by a speaker. ## SYN-SIS OF COAL MINING REGULATIONS.

Coal mining right of the Dominion in Manitoba, Saskatchewan and Alberta, the Yukon Territory, the Northwest Territories and a portion of the Province of British Columbia, may be leased for a term of twenty-one years at an annual rental of \$1 per acre. Not more than 2,560 acres will be leased to one applicant. Applications for a lease must be made by the applicant in person to the Agent or Sub-Agent of the district in which the rights applied for are situated.

In surveyed territory the land must be described by sections, or legal subdivisions of sections, and in unsurveyed territory the tract applied for shall be staked out by the applicant himself.

Each application must be accompanied by a fee of .75, which will be refunded if the right applied for is not available, but not otherwise. A royalty shall be paid on the merchantable output of the mine at the rate of five cents per ton.

The person operating the mine shall furnish the Agent with sworn returns accounting for the full quantity of merchantable coal mined and pay the royalty thereon. If the coal mining rights are not being operated, such returns should be furnished at least once a year.

The lease will include the coal mining rights only; but the lessee may be permitted to purchase whatever available surface rights may be considered necessary for the working of the mine at the rate of \$10 per acre.

### ADVISES DEVELOPING IRON ORE INDUSTRY — William Blakemore Addresses Rotary Club; Says B. C. Should Begin.

Speaking before the Rotary Club at Victoria on the "Mineral Production of Vancouver Island and the Industrial Possibilities Connected With It," William Blakemore referred to the coal and ore deposits of Vancouver and adjacent islands, and expressed the opinion, which he backed up with the views of some of the most eminent British mineral authorities, that the iron and steel industry of this island could be developed profitably, and that it should be encouraged and the large resources utilized at once.

The future of the west, he said, would be found industrially in the ocean traffic of the Pacific. The Atlantic coast had been built up on industry, and the United States now was the largest manufacturing country of iron and steel. Twenty-five years ago they were behind. Eastern Canada had made a beginning with subsidies for the iron and steel industry, but now was able to do without these. The time was coming for development on the Pacific shores. The first move had been made by Japan, from where, some years ago, 40 delegates had been sent to the Old Country to make inquiries and had returned, accompanied by experts, with the result that Japan was now a formidable manufacturing opponent and the third naval power of the world. Japan worked her own iron and coal, and was making a bid for the trade of the Pacific, even though her resources were not comparable with those of British Columbia. There would be a great transportation movement in the future on the Pacific, and the time for this Province to begin had come.

Mr. Blakemore said mineral manufacture was the foundation of any country's industrial development. Agriculture never yet made a country great. It applied as the backbone of a country, but the greatest countries had imported their foodstuffs all the year round, as did mineral manufacturers. He recited the immense number of things imported here that were the result of mineral development, from structural steel to horse-shoes. The coal and the iron were at hand, and experts had arrived at the conclusion that the iron ore and coal deposits could be used here as successfully as elsewhere, and quoted one authority who said there should be a big future in British Columbia for coal distillation and steel making. Thousands of tons of ore from this island had been successfully treated in the United States, and a start should be made here as it had been made on Cape Breton, where, at one locality, the population had increased from 40,000 to 150,000 through the development of mining and the establishment of iron and steel industries.

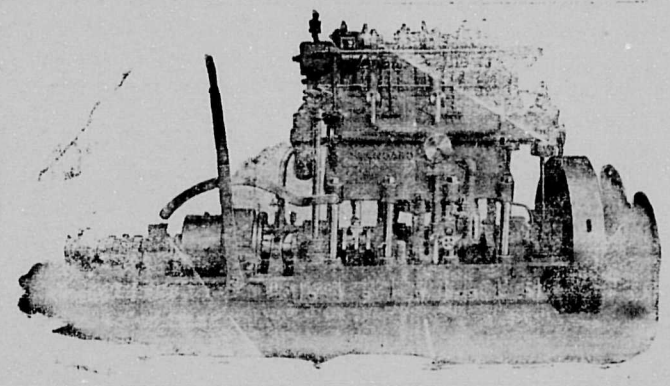

## LOCAL SOLDIERS GIVEN SEND OFF

HOW 102ND BATTALION WAS BID ADIEU IN VANCOUVER ON SATURDAY

Reference Made By Southern Paper To The Men Who Are Representing North.

Referring to the send-off given the 102nd Battalion at Vancouver last Saturday night, when they left for England, the Vancouver Province says:

One of the best sendoffs to an overseas battalion was accorded by the people of Vancouver on Saturday night to the 102nd Battalion, Northern British Columbia (Warden's Warriors). The men were mobilized at Comox Spit and were nearly all personally selected by Lieut.-Col. Warden. As a result of this policy, the battalion will take a lot of beating in the matter of physique.

"I only wish the people of Vancouver could have a chance to see the men on the march," said the Colonel on Saturday night, while regretting that time did not permit of a march through town.

Considering that the 102nd is not a local battalion, the crowd which collected was very gratifying to the men and there was no mistaking the heartiness of the cheers which sped the troop trains away.

The battalion crossed from Comox on the Princess Charlotte and a general holiday was observed at Comox, Union Bay, Courtenay, Cumberland and Campbell River in order that the residents might give the men a send-off.

One of the features of the farewell on Saturday was the presence on the dock of several returned soldiers, who gathered to say goodbye to Colonel Warden, under whom they fought with the first Canadian contingent over a year ago, when he was Captain Warden. Their presence conveyed to civilians the respect and admiration the commanding officer of the 102nd enjoys from his men.

There was also another incident which had its pathetic side. While the men were assembling on the dock one of the privates, in full marching order, was quietly married to his fiancée in the customs office of No. 1 shed. News of the wedding quickly spread and some rice was secured from the shed and as the soldier left the customs office to board the train he was pelted with rice and given three cheers.
