Through this fellowship, the student will receive $\$ 750$ for living expenses, and his university fees for that year will be paid by the Shell Oil Company. The award will be made by Senate on the recommendation of the Joint Faculty Committee on Prizes, Scholarships and Bursaries in consultation with the Heads of the Departments concerned. Full details of the award should be obtained from the Registrar's Office. Applications, on forms available for that purpose, must be received by the Registrar not later than March 15.
2. The R. J. Pop Scholarship in Zoology

A scholarship of $\$ 150$, given annually by Mr . R. J. Pop, will be awarded to the student who completes the third year of the Honours Course in Zoology with highest standing, and intends to pursue an investigation into terrestrial vertebrate Zoology related to the conservation of natural resources. If no third year student presents work of sufficient merit, the award may be made to a student in the fourth year who is proceeding to graduate work in the above field at this or any other University. The award will be made by Senate on the recommendation of the Head of the Department of Zoology.

A survey of major current developments in the field of international relations, with particular attention to Canadian-United States relations within the larger framework of world organization. The following subject matter will be included: Political, economic and financial aspects of world organization. Specific areas and their relation to world organization: Canada and the Commonwealth; Canada and the United States; the United States and Latin America; Europe; Russia; Asia.

The Workshop has been established on the suggestion of the Canada-United States Committee on Education and is intended to bring together in study, discussion and social activities teachers and students from the western Canadian provinces and the western United States, with a view to strengthening understanding between the two countries.
