Mr. Dougherty pointed out that the assignment of rooms to people attending conventions last year had caused a great deal of inconvenience to students who had not vacated their rooms and the intent of the motion was to ensure that this did not happen in the future.

Reports of Committees of Senate (continued)

Budget Committee

Dr. McDowell informed Senate that the Budget Committee intended to report annually to Senate each September. The report would not necessarily give specific financial details since the role of the committee was to advise the President and also because of the nature of the information the committee was now considering and the additional data it expected to develop. It would, however, provide members of Senate with a satisfactory review of its activities and seek to provide an appreciation of the evolving role of this committee.

Report on the B.F.A. Studio Program in Fine Arts

When the B.F.A. Studio Program in Fine Arts was approved by Senate in February 1970 the Dean of Arts was requested to submit a progress report within three to five years. Senate was informed that in 1973 the Dean of Arts struck a committee to review the program. The following recommendations of the committee were contained in the report circulated to Senate: –

- I. Students should be given <u>much more careful</u> counselling so that their academic program becomes more coherent than is generally the case now. They should be encouraged, or required, to take more courses within the Fine Arts Department itself (especially in Art History), and more courses in the other departments of the creative and performing arts.
- II. The Committee became convinced early in its work that reform of the second year studio course FA 281 was essential. This appears to have been accomplished through a reorganization proposed by the Department (see Appendix). In the view of this Committee, thorough and systematic training in this course is the best way to ensure that each student receives the necessary grounding in the techniques of several media. In addition, we recommend that a review of each student's performance be carried out at the end of the second year. The student's achievement and capacity should be assessed and tested in ways more systematic and stringent than is usual in the other studio courses.

Report on the B.F.A. Studio Program in Fine Arts (continued)

- III. The assessment procedures for the third and fourth years, should remain unchanged except that:
 - (a) Students should not be permitted to play a direct part in assigning grades to other students. At the same time, their participation in other stages of the assessment procedures should be encouraged.
 - (b) Assessors should encourage more genuinely critical discussion at the assessment meetings.
- IV. There should normally be no admission to the third year except for students who have completed FA 281 or the equivalent at another institution. At the end of the second year students should be required to demonstrate that they have the technical, academic and imaginative competence to continue in the program.
- V. The B.F.A. program should be funded adequately.
- VI. The Dean should consider what means would best solve the problem of film. The solution might include a central, shared repository of equipment for all departments in the creative and performing arts. This would minimize duplication and perhaps reduce friction. Certainly something should be done to encourage and facilitate the free movement of students among these departments and provide increased opportunities for them to collaborate in experiments to expand their knowledge and appreciation of all the fine arts. In the long run, however, the solution to demarcation problems may be the establishment of a Department of Film, and also of a School of the creative and performing arts.
- VII. The Committee accepts that the B.F.A. program does belong in the university and finds itself in accord with the general aim of providing "a university education for artists". The Committee is also sensitive to the difficulties faced by a new program which must seek to find the proper balance between the theoretical, the technical and the experimental in an area where a premium is placed upon imagination and self-motivation. In view of such factors as these, the Committee recommends that a further review of the B.F.A. program be conducted in three years' time.

In the report of the Dean of Arts it was stated that he intended to bring about the implementation of Recommendations I, III and IV. The proposed reform of Fine Arts 281 referred to in Recommendation II had been carried out satisfactorily, and the review of students' work also proposed in that Recommendation was covered

in Recommendation IV. Referring to Recommendation V it was stated that a great many programs in the Faculty of Arts would benefit from increased funding and the needs of the studio program would be assessed in relation to the availability of funds and the overall priorities of the Faculty. The problem referred to in Recommendation VI had been solved to the satisfaction of all concerned by an agreement between the Department of Fine Arts and the Department of Theatre.

Faculty of Medicine

In the proposal circulated to Senate it was stated that in the first round of operation of the three-year program it was evident that the course content of Second Year could not be satisfactorily covered in the time allotted. The Faculty was therefore proposing to move approximately 60 hours from the first term of Second Year to second term and extend the year for two weeks at the end.

School of Nursing

A proposal to limit enrolment in the School of Nursing, effective for the 1976/77 Academic Year, had been circulated. It was stated that the reasons for the proposal were principally a shortage of facilities. The numbers were chosen to stabilise the present overall enrolment of the students since without such a quota there would be further tremendous growth in enrolment. The School's proposal had been discussed extensively within the School and with its Advisory Committee and the Council of the School of Nursing as well as with the Executive of the Registered Nurses Association of B.C. All agreed on the necessity of some type of quota. The selection and admissions procedures to implement

such a quota are under consideration and Senate will be kept informed of the regulations developed.

Dr. Uprichard) That Senate approve the proposal of the Dr. Copp) School of Nursing to limit the enrolment in the School by restricting the admission of students, effective for the 1976/77 Academic Year, as follows: -

Admission into First Year of Nursing: 113 students
Registered Nurses admitted into the
Third Year (in addition to the Second
Year students continuing into Third
Year): 50 students

In reply to a query Dr. Uprichard stated that the School would need to take in 113 First Year students for each of the years between 1976/77 and 1980/81 but that this was a projection and may be changed as the situation changes.

Other business

Expansion of the Medical School Enrolment

The Chairman reported that on March 4 he had received a letter from the Minister of Education indicating that the Government was most concerned that several hundred qualified students from British Columbia were being turned away each year from Medical School while there was a demand in the Province for almost four times as many doctors as were being turned out by this University. The Government had given the University 60 days to come up with an acceptable plan for doubling the enrolment in the Faculty of Medicine, and a plan for a 240 bed community teaching hospital on campus and the upgrading of teaching facilities in affiliated hospitals. If the University could produce an acceptable plan \$50 million would be made available, half from the federal Health Resources Fund and half from the provincial government.

The Chairman stated that he immediately called a meeting of the Dean of the Faculty of Medicine along with the Clinical Heads of that Faculty and the Academic Heads, and in addition all of the allied health professions such as Pharmaceutical Sciences, Dentistry, Nursing and Rehabilitation Medicine. It was felt that the University should consider the request of the government to see whether it could formulate a proposal. The Chairman assured members of Senate that he had indicated to everyone in the Faculty of Medicine and the allied health fields that if it were possible to formulate a plan it should be done but if on the other hand this would mean a deterioration in the academic standards that should be indicated to the government. It was also felt that the service role of the 240 bed teaching hospital should be established in consultation with the existing teaching hospitals, and that it was important to examine the need to uprgrade the academic

clinical teaching facilities in those associated hospitals. The Chairman reminded Senate that any increase in enrolment would have to be approved by the Board of Governors and Senate.

Universities Act

In reply to queries about possible changes in the <u>Universities Act</u> the Chairman reported that he had been in touch with the Department of Education in Victoria and had been assured that there would be no major changes in the Universities Act this session of the House.

Membership on the Board of Governors

Dr. Clark gave notice of the following motion: -

"That Senate regrets the action by the Honourable Patrick McGeer, Minister of Education, in removing two appointed members of the Board of Governors of The University of British Columbia prior to the completion of their term of office."

Student membership on Senate

On behalf of Senate the Chairman expressed thanks and appreciation for the contribution made by those student senators who were attending their last meeting.

The meeting adjourned at 11.00 p.m.

APPENDIX 'A'

New awards recommended to Senate

The B. C. Foundation for Non-Animal Research Fellowship

A fellowship in the amount of \$3,000 has been made available by the B. C. Foundation for Non-Animal Research to support a student majoring in human tissue and cell culture techniques in cancer research. The award will be made on the recommendation of the Faculty of Medicine.

The Fraser Valley Milk Producers' Association Bursary in Animal Science

A bursary of \$300, the gift of the Fraser Valley Milk Producers' Association, is offered annually to a student entering Third Year Agricultural Sciences and specializing in Animal Science. The award will be made to a student who has a special interest in a career in the dairy industry. Should no Third Year applicant be considered suitable, the bursary may be offered to a student entering the Fourth Year.

The Hospital Employees' Union (Royal Jubilee Unit) Bursary

A bursary in the amount of \$350 is offered by the Royal Jubilee Unit, Victoria, of the Hospital Employees' Union, Local 180. The award is available to students who are proceeding in the Fall from Grade 12 to a full program at The University of British Columbia, the University of Victoria, Notre Dame University of Nelson, Simon Fraser University, or any of the regional colleges in British Columbia, in any field leading to a degree, or leading to a diploma of technology at the B. C. Institute of Technology. To be eligible, an applicant must be the son or daughter of an active member of the Union ("active" being interpreted as on the staff of a hospital within the jurisdiction of Local 180, superannuated). The information given on the application must clearly establish the applicant's connection with Local 180. The bursary will be awarded to the candidate who in the opinion of the University (in consultation with the Union) is best qualified in terms of financial need.

The Vladimir J. Krajina Scholarship in Plant Ecology

This scholarship has been made available by his friends, colleagues, and former students. The award is in recognition of Dr. Krajina's significant contribution to The University of British Columbia, not only while he was a member of the Department of Botany, from 1949–70, but also subsequent to his retirement in 1970. His outstanding contribution to the development of the Ecological Reserves in British Columbia represents the culmination of a long and successful career as one of Canada's foremost plant ecologists. The award will be made annually to a graduating student who has achieved an outstanding performance in Botany 426 and 427, and who plans to proceed

to graduate studies in the field of terrestrial plant ecology. The award will be made on the recommendation of the Department of Botany.

John B. Macdonald Scholarship

In honour of John B. Macdonald the fourth President of U.B.C. alumni and friends have established a Scholarship in the amount of \$300. The award will be made to a student demonstrating academic achievement, and leadership in and service to the University community. In order to qualify, students must have attended the University for at least two full winter sessions and be qualified in the next winter session to enter the third or higher year of study.

The Elizabeth Tong Ng Memorial Scholarship in Asian Studies

This scholarship, in the amount of \$500, will be awarded to a final year undergraduate student in the Department of Asian Studies on the basis of both academic ability and financial need. The award will be made on the recommendation of the Department.

The Elizabeth Tong Ng Memorial Scholarship in Medicine

This scholarship, in the amount of \$500, will be awarded to a final year undergraduate student in the Faculty of Medicine on the basis of both academic ability and financial need. The award will be made on the recommendation of the Faculty.

Admission Requirements

- Bachelor's degree equivalent to the B.S.W. of the University.
 Applicants with deficiencies in undergraduate courses in Social Work or with a Bachelor's degree in a related field are admissible; but may be required to complete up to 18 units of preparatory work.
- 2. The academic standing requirement of the Faculty of Graduate Studies, i.e. First Class standing in at least two (6 units) courses and at least Second Class standing in the remaining courses prescribed by the School as prerequisite to the Master's program.
- 3. In admitting a limited number of students to the program, preference will be given to applicants with professional experience in Social Work.
- 4. (a) Preference will be given to applicants who have completed S.W. 425, Social Work Research Methodology, or an equivalent course.
 - (b) Applicants planning to specialize in research and to complete a thesis are required to have completed S.W. 425 or equivalent; and, beginning in 1978-79, will also be required to have completed introductory course work in statistics. U.B.C. courses through which this requirement may be met include Anthropology 418, Education 482, Health Care & Epidemiology 400, Psychology 316, Sociology 451.
- 5. The M.S.W. program provides a choice of three concentrations (see Program Plan below):
 - (a) In the Health Needs and Family Needs concentrations, preference will be given to applicants whose undergraduate program includes courses in Sociology and Psychology.
 - (b) In the Socio-Economic Needs concentration, preference will be given to applicants whose undergraduate program includes courses in Economics and Political Science; and, beginning in 1978-79, applicants will be required to have completed Economics 309, Principles of Economics, or equivalent.

1. Candidates for the M.S.W. degree are required to meet the general requirements for Master's degrees of the Faculty of Graduate Studies.
