## THE RICH JEWEL LEAD

Over 5,000 Feet of Work Done on the Best Known of the Long Lake Claims—A Very Rich Lead Requiring Intelligent Management.

In the year 1895 a band of hardy pioneers were operating in the Greenwood district. Some of them still remain in the country, others have left for pastures new, while others have crossed the great divide and are remembered no more. During this year Long Lake was discovered and the mining claims on the east side of the lake located. The headquarters of the prospectors were mostly at Boundary Falls, at which point supplies were purchased and necessary repairs, such as blacksmithing done.

The deal at present pending between the Jewel company of London, Eng., and the Le Roi No. 2, limited, of London, Eng., and Rossland, B. C., by which it is hoped the latter company will purchase the mines and properties of the former with a view to opening up the Long Lake camp again after years of idleness, was the primary reason for a visit to the camp by a representative of The Times this week. Nothing definite can be learned as to the probable outcome of the negotiations which have been in progress for some months past, but the Jewel is such a valuable property that on this ground alone it is expected the Rossland company will purchase and work the property as it should be worked, and as it might have been for the past few years had not the officials in London endeavored to manage the mine from their end instead of letting a most capable manager do it from this end. The gentleman in question got so disgusted at last with the unending contradictory orders received, that he quit the mine and it has since remained idle.

The main lead in the camp is the so-called Jewel lead, which was discovered on the Denero Grande by C. J. McArthur of Greenwood after the Jewel was located, but which ran through the Jewel location. Quite a list of claims are on this lead, beginning at the south, the Greenwood end, there is the DENERO CHEKO

located by Fred Shonquest and at present owned by the mayor of Greenwood, Geo. R. Naden. The meaning of the words denero cheko is "little money." The next claim north is the DENERO GRANDE,

located by C. J. McArthur and Fred Shonquest, and on which the main lead was discovered. A half interest in this property was bonded to the Jewel company this spring by Mr. McArthur for the sum of \$16,000, payable in one year, from the date of bond. The Jewel company were the owners of the other half and evidently wanted the whole of the property in order to be in a position to deal with the Josie people. It was this deal which first started the interest in Long Lake camp and gave those interested in the doings of this district an inkling of a possible revival this summer. The main lead runs practically due north and south, and the next claim to the Denero Grande to the north is the JEWEL.

on which the great bulk of the development work so far done in the camp has been confined. The Jewel was located by Frank Dittmer and Louis Bosshart. The latter gentleman, as is well known to many, is at present in Greenwood on one of his periodical visits from the camp he is now interested in between the West and the Main forks of the Kettle river.

On the Jewel there is a main shaft, sunk on the lead, 300 feet deep, with drifts on the 50, 120, 200 and 300-foot levels. These drifts total in all about 3,500 feet of work including raises and shafts, the total amount of work done on the property is nearly 5,000 feet. Altogether the sum of \$150,000 has been spent in development work.

When the Columbia and Western was built the company started shipping ore from Burns' siding, the nearest railway point to the mine and a trifle over three miles distant, and before the mine was closed had shipped

some thousands of tons of ore. The vein averages 42 inches in width but widens out and narrows very much in places. Where the vein is very wide it is of low grade, and where it is narrow it is very high grade, some of it has been known to run as high as \$500 to the ton. The whole of the ore will perhaps average \$12. Before the mine was closed it was decided to build a cyanide plant and treat the ore on the property. For the purpose of getting the lumber for the buildings the company erected a sawmill on the lake front at the south end. It was used but very little and is still intact. After the mill was finished orders were received from England not to go ahead with the cyanide plant and the manager of the mine went home.

The mine is equipped with a small hoisting engine, not large enough for working the mine at its present stage of development, a 5-drill compressor, two 80-horsepower boilers, two sinking pumps and a large station pump at the 200-foot level.

North of the Jewel are the ENTERPRISE AND ANCHOR claims, the former is a fraction and was located by Geo. Leeson, and the latter by S. Benneman of Midway. Both are now owned by a company in which Mackenzie & Mann own the control, and owing to whose methods the properties are idle today, with no prospect of being worked.

Next follows the ETHIOPIAN, located by Robert Patterson and Dan Stewart.

The Robert Emmett is the next claim and was located by C. J. McArthur. The Idaho is the next. It was located by John Luce of Greenwood, who still owns a one-third interest, the other two-thirds interest being owned by the estate of the late P. J. Largey of Butte, Montana.

This comprises the full list of the locations, claims and mines on the main Jewel lead. To the west on the lake front there are some promising properties named the Prince Albert, Gold Bug and Lakeside.

The Jewel company own some other claims to the east of their main property called the Imperial, Massachusetts and Gold Drop. No work has been done on the two first, but a 40-foot shaft has been sunk on the latter and the highest grade ore taken out that was ever discovered in Greenwood camp, rich in both gold and tellurium.

All these properties are on the east side of Long lake, which is about two miles long and half a mile wide at the widest point. The lake is located to the north of Greenwood and can be reached by a good wagon road branching from the Eholt road. Two years ago the lake was stocked with trout spawn from the neighboring lakes and streams and it is expected that in time it will be a fine fishing resort.

The present wagon road follows the old trail cut in 1895 by about twenty of those interested in the camp. It was cut about eight feet wide and can still be found in places where the wagon road has deviated somewhat from the old trail. It took but three days to cut out.

Long lake is drained by Granite creek, which flows into Eholt creek at the foot of Eholt meadows.



TWO FEET ON TWIN.

A Rich Paystreak Crosscut This Morning.

This morning on the Twin a very fine paystreak was crosscut in the face of the tunnel 70 feet from the portal. The vein at this point is running nearly north and south and dips to the east at about 45 degrees. The lead is about 2 feet 6 inches in width and the paystreak is in the center of it. It is composed of copper pyrites and galena, and judging from the looks of the sample obtained, runs well in gold.

The tunnel in which the find has been made was started June 1st last on a 6-inch ledge lying almost flat, and which has gradually widened and straightened, until now it looks most promising. Only two men are working on the property.

THE WASTE DUMP.

The manufacture of paper from peat is still in the experimental stage, and only the poorer grades of wrapping paper are made from this material. Zinc white is competing with lead in the manufacture of paints. The zinc pigment is not subject to discolorations which the lead compounds undergo.

A new steel produced in Sheffield possesses some rather paradoxical properties. Notwithstanding the fact that it is hard enough to cut glass, it will bend easily.

The well known power of porous carbon to absorb gases probably renders coal dust more dangerous as an explosive than it otherwise would be.

Mexican silver dollars are still in demand in China for the displacement of innumerable local taels now in use in the different provinces. The demand will probably continue for some time.

One half of Canada's production of corundum—an excellent abrasive for polishing and grinding metal—is shipped to the United States.

Eight feet of drilling per day in quartz, and 12 to 14 feet in feldspar, is considered a day's work in the mica field of Southern India. The deepest hole is four feet. Country powder is generally used in blasting.

Plate glass is made by pouring the mixture upon a table having a marginal edge of a height equal to that designed for the thickness of the glass. A roller travels over the table, on the ledges, and flattening out the glass and making it of equal thickness throughout.

England adopted the single gold standard in 1816, Portugal in 1854, Germany in 1871, the United States in 1873, the Scandinavian states in 1874, Holland in 1875, France in 1876, Austria-Hungary in 1892, British India in 1893, Japan in 1898, Russia in 1899 and Mexico in 1905.

Glance is a term applied to certain opaque minerals of which the high

lustre and color indicate their metalliferous character. Chalcocite is known often as copper glance. Stibnite as antimony glance, argentite as silver glance, galena as lead glance, hematite, specular iron ore, some varieties are known as iron glance, and sylvanite as yellow gold glance.

Moiature may be successfully removed from compressed air by conducting the air from the receiver through a reducing valve or pressure regulator into a second receiver having a drain valve in the bottom. The air passing through this apparatus will be found to reach the machines in a dry state.

In handling steel or iron in large quantities by a crane, a lifting magnet will be found greatly superior to chains, hooks or clamps. Magnets are instantly attached or detached, thus saving much time. A current of from one to twelve amperes is necessary, according to the work to be done.

Sunlight is an active agent in producing chemical changes, and the recent speculation as to its effect on the cyanide process is interesting. It can be shown that sunlight aids in the absorption of oxygen by the cyanide solution, we may look for decided changes in methods of construction and operation.

Steam gauges will indicate correctly only when properly placed. If a gauge is so placed that all water drains back into the boiler, it will indicate correctly; but if the connecting pipe contains water, the gauge will indicate less or more than the actual steam pressure, according as the weight of the contained water either counteracts or augments the steam pressure. The indicated pressure will be in error one pound, up or down, for each 27.7 inches of water remaining in the connecting pipe.

The usual theory of the stability of masonry dams assumes, but two ways in which failure may be expected, by sliding bodily off its foundations or by a bodily break in a horizontal line near the toe. The new theory, which is attracting so much attention, apparently demonstrates that rupture may take place in a vertical line before failure by horizontal separation can occur. The factor of safety against the vertical rupture is stated to be only one half to two-thirds that which is usually used against horizontal rupture. If this is true it will be apparent that existing dams of this nature are amply safe. —Mining-Reporter.

PRESS COMMENT.


Not long ago we received a letter from an investor who resides near the Atlantic, asking "if there were any honest men in British Columbia?" says the Lardeau Mining Review. He had lost his money in mining, not through the failure of the property, but through the operations of people in his own state. The property is today in good shape and will undoubtedly prove a dividend-payer, but the promoters of the original company failed and this particular individual lost his money, and now he curses British Columbia. We have had letters from other eastern parties along the same line on another property. On enquiry we found this property was bonded and payments were to be made monthly. The property was stocked for a large amount and \$30,000 worth of stock sold. The promoters pocketed a large portion of this, paid part of it on the property and did some development. Today the stockholders who put in this \$30,000 have nothing to show for their money. The bond has lapsed and the investor curses the country. He was bounced out of his money by his own people not acting honestly with him. The property is a good one and worth every dollar asked for it. The millions lost in the Le Roi were not lost because of failure of the property, but because of the rascality of the London operators. We can cite hundreds of other instances where failure has come and the investor has lost because of either the incompetency or dishonesty of his own people. But poor old British Columbia has to stand the racket. We say without fear of contradiction that the resources of British Columbia both in minerals and timber are such that if the money invested is carefully and judiciously expended the chances of failure as small as in any other line of business. Now, Mr. Loser, be honest; find out the channel through which your own people have wasted your money; and if you can afford it, come out to B. C. and you will find that the country is teeming with wealth and the people straight.

Hamilton Times: One of the visiting ministers, a Rev. Dr. Bell of San Francisco, was guilty of an act of bumpiness and bad taste at the International Sunday School Union in Toronto yesterday that is not to be easily excused. He launched out in an annexation harrange and declared that we should be "under the same legislature, under the same lawmakers, under the same great national institutions," and he hoped to live to see the day when we should be all "Americans." The untimely and insulting sentiment was received in dead silence. What a pity somebody hadn't talked back!

Vancouver World: The report of the military board of enquiry into the so-called "army scandals," extracts from which have been cabled during the past week, comes somewhat in the nature of a shock to "colonials," who have been accustomed to look upon the British army officer as a being "sans peur et sans reproche," incapable of jobbery or graft as the art is known on this side of the world. Putting the most favorable construction upon the fragments of the report which have reached us, the only conclusion possible to arrive at is that a very grave state of affairs has been unearthed in the army supply department, and that a thorough reorganization of that branch of the service is imperatively necessary. Speaking of the report, Public Opinion says: "Ruthless exposure and condemnation of the practices of contractors and officers responsible for the supply of stores to the army during the South African war is the result of the inquiry presided over by Lieutenant-General Sir William Butler. In issuing the blue book the secretary of state is careful to point out that in many instances the case is not proven, and that the evidence is necessarily incomplete, the explanation seems often to be a convenient loss of memory as to facts by implicated individuals. The scandal of the whole business is much greater than even the worst enemy of the contractors imagined, and unfortunately incompetence and indifference supplemented corruption."

The Chinese in the Transvaal are granted the same trading licenses as are the whites. On this account the latter are finding it rather hard to continue in business. The Asiatics bid for the patronage of their fellow countrymen working in the mines and are of course successful, to the detriment of the trade of the white storekeeper. The matter will be considered by the Transvaal government.


